1. **This Assessment** is being conducted under the Rules and Regulations of the New Zealand Kennel Club (Incorporated).
2. **The Amount** of fees and expenses shown overleaf is subject to approval, in advance, by the Society conducting the assessment (New Zealand Judges note Show Regulation 6).
3. **The Club** conducting the Assessment reserves the right to reallocate one or more levels to another assessor if an excessive number of entries is received.
4. **The Assessor** is to advise the secretary of the Club whether or not this invitation is accepted. If the reply is not received by the secretary within 21 days of the date of the offer, it will have been deemed lapsed.
5. **If the Assessor's** fees, accommodation and/or expenses are not confirmed by the Club within 14 days of the date of acceptance, it will have been deemed lapsed and this contract is at an end.
6. **Air or other Travel** If a specified mode of travel, including conditional methods of air travel, is required of or by an Assessor, these should be specified and full particulars of this travel should be given. In the absence of such specification, an Assessor is entitled to full Economy return air travel on the schedule specified by the Assessor. (**NB:** The method and responsibility for the booking and payment of fares should be clearly agreed upon by the parties to this contract).
