#### 2. IMPORTANT ITEMS

#### STRATEGIC

NT had asked time be set aside for a "strategic session". Discussion centred on "vision statements" – should it read "go to organisation for dog owners" or be more specific focusing on what we do? First requirement is to establish a Mission Statement i.e. why we exist or what we actually do. PD to arrange a facilitator for the Saturday (24 November).

Trade Me to be added to the list of "audiences" in the Communications Plan. It was noted that interaction was held with them.

#### SOCIAL MEDIA (SM)

The draft "Policy Statement" SM Code of Conduct was tabled for discussion. Agreed that "Policy Statement" be removed from title and document. Under "Breach" remove first paragraph. Updated code to be circulated for sign off and noting in Dog World.

#### DOGS NZ PROPERTIES

NT had asked that this topic be placed on the agenda under strategic given the importance of the three venues to Dogs NZ. PD confirmed all properties have been alerted to the need for "10 year" thinking and all are pro-active in this approach as clearly demonstrated in the reporting. A basic "assessment" document is in draft form and will be circulated once the three national events are behind us.

#### **SELECTIVE BREEDING**

The matter of selective breeding, as highlighted by NAWAC in their opinion paper, has clearly demonstrated the need for Dogs NZ to make a clear distinction between our breeders, their dogs and the rules, regulations, codes of ethics and health testing they are bound by and subject to and those non-member breeders who are totally unregulated.

Clearly a focus is being placed on certain breeds by NAWAC in the early part and Dogs NZ has already been proactive in addressing this. A meeting was held with the Southern Bulldog Club on 28 August. The club will progress their Taskforce as promoted at ACOD working with the other three bulldogs clubs and the French Bulldog Society and work independently of Dogs NZ. BW was not comfortable with not being extended the opportunity to attend the meeting. The current Dogs NZ Brachycephalic Working Group will be disestablished as it stands and be reformed with an ad placed in the Dog World calling for applications from breeders of the four most popular brachycephalic breeds to join members of the CH&W Committee. All clubs will also be contacted directly. The promotion of health testing and healthy progeny will remain the focus of both groups. Proposal recommended to meeting.

# ANKC AGM

The invite to the ANKC AGM and Board meeting was further discussed. PD will firstly check the dates of the ANKC Board meetings to see if they coincide with those of Dogs NZ (particularly 24/25 November) as it was felt that a full Video Conference of both boards may be more effective. If a Video Conference does not look viable then NT will look to attend.

# FCI ASSOCIATE MEMBERSHIP

Given that the ANKC had now resolved to sign off on an agreement to continue as a FCI Associate Member it was agreed that Dogs NZ should be proactive in making an approach to FCI regarding similar terms and conditions.

#### ACCREDITED BREEDERS SCHEME (ABS) REVIEW

BM tabled a six page report from the CH&W Committee providing a summary of recommendations and a proposed process as the initial findings in the review of the ABS. The first part of the process is for EC members to provide feedback to BM by Friday, 22 September highlighting perceived issues, barriers to entry and possible solutions. An updated draft will then be presented to the CH&W Committee for a selected membership survey to then be drafted. It is intended that the tiered scheme structure will also outline where other registered Dogs NZ breeders fit in the overall scheme.

# EC "POLICIES & PROCEDURES REVIEW

The second "4 of the 15" documents were tabled for review. The recommended changes will be made and circulated for inclusion in the EC folders. Another 4 documents will be included in the November papers for a similar review.

# 2017 ACOD REVIEW (UPDATE)

A summary of actions already taken and matters noted for implementation at the 2018 ACOD were tabled. Proposed 2018 remits will be tabled at the November meeting.

# 2017 ACOD DISCUSSION PAPER 2 – BREEDING OF CROSSBREDS

The discussion points from ACOD were listed in the EC papers & it was agreed a workshop be held in November on this subject given its importance to Dogs NZ and the overwhelming support from the floor that registered breeders be discouraged from the practice.

# 2017 ACOD DISCUSSION PAPER 3 – THIRD CHAMPIONSHIP SHOW

Once again the discussion points from ACOD were listed in the EC papers and it was agreed that these thoughts be embraced and considered by the "Blue Sky" group. The small number of All Breed judges in NZ was noted.

# 2018 ACOD

The 2018 ACOD timelines were set out in the EC papers and noted.

# SUB-COMMITTEES/COMMITTEES

An updated list of the current sub-committees/committees was tabled and will be placed on the Dogs NZ website. It was noted that the management of such a large number of sub-committees/committees brings challenges in terms of adherence to Dogs NZ strategies, general direction, planning and reporting. Consequently, it was agreed that all should have Terms of Reference in place. PD to progress with the relevant Chairs. A review is also to be undertaken on the frequency of appointments for all sub-committees/committees and thoughts were offered and noted in relation to these. The current practice of advertising for "expressions of interest" in the July Dog World for some sub-committees/committees in consultation with the relevant Chairs was also discussed. There was agreement that the latter is important for efficient functionality. EC Liaison Officer roles to be disestablished in 12 month trial. A draft over-riding document will be placed in the November EC papers for further discussion. NT suggested that the Audit & Risk and Health & Safety sub-committees be merged but it was determined that these remain stand-alone in the interim. PD to approach Ann Coulson to chair Audit & Risk.

KB recommended that KMcI & LS be appointed to the CH&W Committee.

# CLUB SURVEY

Key points from the survey (176 responses) were set out in the EC papers as were a number of the question summaries. A hard copy document will be provided to NT, LS and KMcI (as part of Blue Sky consideration. The document will also be placed on the EC section of the website. PD to refresh EC on the workings of the relevant section. The basic extrapolations of membership numbers was questioned by EC.

# **BENEFIT SHOW (BS)**

A late advice was received from Wanganui KS to hold a BS on 24/25 March, 2018 in conjunction with their Championship Shows.

Moved; LS: Seconded; MMcK – passed (SM against) The advice was lodged on the new, standardised form as recommended be put in place by EC. CH noted that it did not include provision for information on other means of fund-raising undertaken. PD to add.

# RISK REGISTER

As required the current register was tabled for discussion. PD and GS to sectionalise and in the first instance send CH the section relating to Health & Safety.

# EC ATTENDANCE AT NZDAC & NDOA

GC NDOA BD NZDAC MMcK NZDAC (Sunday only) ST confirmed as attending NZDAC (Saturday) and NDOA (Sunday). In both cases he will be driving. PD to advise both committees.

#### 2017 NDS

Report provided by Gary Withers (Chairperson)

- Final full committee meeting has been held focusing on overall financial result and the staging of a successful show
- Entries down about 10% in line with other shows
- 2 successful grants received for \$2k (Akld CC) and \$10k (Trillian Trust)
- Forecast loss of between \$10-15k

A photo of the motorway billboard was included in the EC papers attracting favourable comments. SM advised there is a dinner being held at the conclusion of the show at Ardmore for those still in Akld. Request that EC members be at VEC by noon Thursday for assistance with the set-up. PD confirmed that MP has acted on request to follow up on TV coverage. PD to discuss with GS the provision of cash (prizes) for the Prelude. Noted that the card for challenge certificates was too flimsy. PD to query. PD to ask GS if it is possible to extract the Obedience costs from the NDS & Prelude. Noted that there have only ever been two cost centres before & that separate budgets were not provided.

# 2018 NDS

- Parking will again be challenge and campervans to be considered.
- Volunteer interest already is pleasing
- 2 of 3 judges signed contracts returned with other imminent
- Activity timelines set out

 Final day format discussed. At PD's request MMcK had provided an oversight of other major shows held off-shore. The key change will be no in-show awards other than puppy in show. A number of other initiatives were discussed. MMcK will summarise these with PD to email EC for sign-off. Support of the format was recommended:

- Well attended Member Forum held the same day
- Board Meeting held on 15 & 16 August with emphasis on strategic direction. Need for Dogs NZ to determine what of its activities fall under the "companion animal" banner.
- Brian Harris submitted a NZ Companion Animal Trust meeting report from 27 July

# SOUTH ISLAND "BLUE SKY" SHOW CALENDAR UPDATE

A SWOT analysis as undertaken raised a number of questions for further debate and a subsequent need to address these from different perspectives. The next step is to undertake a targeted survey on the questions identified. KMcI to provide PD with questions to install on Survey Monkey.

EC agreed group was moving in right direction and had no issue with club survey material being utilised and own survey being undertaken. Recommended that registry "numbers" may also provide context.

# NDS JUDGES

It was agreed that there was little to be gained from dwelling on the 2017 situation. Following on from the 2016 issue and discussion regarding 2018 and beyond it was recommended that the Dogs NZ NDS judges not be shared prior to our event and that this be reflected in the contracts "not to accept a judging appointment in Australia within 6 months of this appointment"

BW tabled suggestions for reserve (back-up) judges in 2017 should the need arise.

#### 3. OFFICE REPORTS

# DIRECTOR/SECRETARY REPORT (Matters not reported elsewhere)

- Two local club meetings have been held of late in Porirua. The first involved the 5 All Breed clubs in addition to the two from Kapiti Coast. It is intended to put in place an umbrella group to oversee but mainly assist in the running of all Championship Shows at Porirua in addition to instigating a number of new initiatives. The second meeting was open to all Wgtn clubs and is essentially a venue AGM. The key topics involved the maintenance and enhancements to the building particularly.
- key topics involved the maintenance and enhancements to the building particularly in light of the 2018 NDS being held here again in October.
- A meeting was held with NZGRA who are looking to contract a Dogs NZ trainer for a pilot project at Rimutaka prison.
- The last of the 2016/2017 JDH heats was held at the Porirua Benefit Show on Sept 9.
- Nine submissions regarding the proposed change to the Shih Tzu Breed Standard have been passed onto the committee for further consideration.
- A questionnaire in relation to the "weighing of Miniature Daschunds" has been developed and will be advertised and circulated immediately.
- The inaugural meeting of a Companion Animal Training & Behaviour Accreditation Group (CATBAG)was held in Wellington on August 30 Groups represented included SPCA, NZVA, AUT, BARK, MPI, Pet Dog Trainers Assn and Dogs NZ (both GC & PD). Many overseas models were presented with both regulation and accreditation discussed.
- With the focus on the 3 x National events further work on the website and OSP has been minimal of late.
- Mercury IT is working well with the Registry team with enhancements to the Registry data-base. A colour drop down box is now in place for the Labrador and in a similar pilot the health test results will be implemented for the same breed. Once installed and tested both initiatives will be introduced wider commencing with the more popular breeds.
- The initiative to encourage more breeders to register progeny on the Full Register rather than the Restricted Register based on price is working with only 21% of progeny being placed on the latter (previously 43%) albeit with the measure only able to be taken over a 2 month period.

# TREASURER'S REPORT

- The July financial reports (summarised) were included in the EC papers. The A&R Subcommittee had previously received a full set.
- Net cash surplus to July 31 stood at \$39,495 against a budgeted figure of \$83,600. A one-off timing issue was noted (favourable).
- A July breakdown (2016 to 2017) highlighted a fall-off in Registry income.
- A separate report was tabled for the NDS & Prelude. The current forecast loss is between \$15-20k with \$10k pending in relation to a funding application.
- Total cash at 31 July was \$1,531k and up from the 30 June figure of \$1,384k.
- Under Financial Review recommendations for increases in fees for Kennel Renewals, Litter Notifications and Transfers were set out. LS spoke of further increased costs for breeders. ST requested that an assessment be made of the impact of CPI (lack of such application) since the last adjustment. PD to provide prior to an email vote for support or other.

# Lorde of Charlesworth 04460-2014 Golden Retriever owned by S Charlesworth

This dog has now completed 6 observations without incident and is no longer on report – owner advised.

# Bushsong Ironjade Topazhikaru (IMP –AUST) 5100088824 Tibetan Mastiff owned by C Chester and E Kuo

The owners have advised the dog has been undertaking training and has since been shown and observed at two shows without incident.

# Maslaghan Under Pressure 07057 – 2016 Shih Tzu owned by V & G Hose

The dog has been shown and observed at one show.

# Bullestate Red Cloud at Shiann 05760 - 2016 Bulldog owned by S Robertson

The dog was dismissed from the ring at The Plains KA's Championship Show on 3 September for aggressive behaviour. The owner was advised by the Show Manager of the 7 day standdown period and by the office of the six required observations. The judge has been emailed for comment.

# Federal Star of Justice JD RN 02922-2015 Pyrenean Sheepdog Long Haired - owned by T Page

The dog was excluded from the event by the Test Manager at the Taieri Canine Training Club's Championship Event on 3 September for its menacing disposition towards the judge. A judges report has been received and the owner advised by the office of the six required observations. The owner has written letters of apology to the judge and Agility Committee.

# Lone Ranger of Sarelle CDX 03867-2013 German Shepherd Dog - owned by M Ingham

The Test Manager at Hawera Dog Training Assn's Championship Obedience Test advised that the dog (GSD) broke from a stay and attacked another dog. A third dog also became involved culminating in an owner being bitten. Two dogs and the owner required treatment.

The GSD was excluded from the show and the owner advised by the office of the six required observations. The owner has advised the dog will not be taking part in Obedience for some time but has since taken part and been observed in two Agility events. The owner has indicated that the dog (male) is to be neutered.

There was discussion regarding the relevance of agility observations vs at obedience events. This matter is to be considered further.

# CANINE HEALTH & WELFARE OFFICER (Dr. Becky Murphy in attendance)

- Accredited Breeders Scheme numbers remain static albeit with 7 new and 10 resignations. The latter are due to an inability to provide test results for sire and/or dam.
  There have been 9 breaches of the BCOE over the past 4 months.
- Inere have been 9 breaches of the BCOE over the past 4 months.
   Attended meeting with MPL (with PD) to discuss proposed gnimal we
- Attended meeting with MPI (with PD) to discuss proposed animal welfare regulations particularly tail docking and dew claw removal. The Dogs NZ displeasure at the lack of science based justification for the intended ban on tail docking (banding) was expressed. MPI suggested a joint meeting with Veterinary Council on dew claw removal. BM to confirm. A Dogs NZ draft letter to MPI was tabled and will be sent on behalf of NT and BM.
- Tri-coloured Bulldog. A DNA test had been requested and was undertaken. Given the results the progeny will be registered but the owner has been advised another test is required (at Dogs NZ cost) to be taken by BM at the NDS.
- It was recommended that an Animals in Entertainment sub-committee be formed to take a pro-active approach to the upcoming NAWAC review. PD to approach Agility with GC (Obedience) and LS (Breed) confirmed at the meeting.
- NZVA collaboration. NZVA CAV are keen to be involved in Dogs NZ seminars relating to responsible breeding. This then becomes an opportunity for education for veterinary surgeons and breeders alike. They are also keen to assist in the development of puppy packs for ABS members in the first instance.
- Brachycephalic Obstructive Airway Syndrome (BOAS) chamber. An opportunity exists for Dogs NZ to be proactive in the importation of a chamber to diagnose BOAS at a time when concerns are being raised with regard selective breeding and particularly in relation to brachycephalic breeds. Funding opportunities to include a Dogs NZ contribution were discussed as was where such expenditure rates in terms of priority order.

# CH&W Committee meeting report (28 July) - matters not covered elsewhere

- DNA testing of exported dogs recommendation that where parents are alive and available the dog for which a CEP is to be granted should have parentage proof by DNA. Furthermore, it was recommended that a preferred or exclusive New Zealand based DNA laboratory provider is sought to address cost and turnaround issues. The meeting agreed that a recommendation on the latter should precede a decision on the first recommendation.
- CH&W committee looking to draft a DNA general policy for Dogs NZ given the increased availability and utilisation of this form of science.
- NZVA Elbow Dysplasia Scheme CH&W committee had been asked for comment on the scheme by NZVA. They do not support its continuation in its current format. It will be communicated that support would be conditional upon it becoming faster and digital.
- Definition of brachycephalic breeds. On approach NAWAC confirmed they do not have a list of such breeds.

# 5. CLUB MATTERS

# DOMINION BULLMASTIFF CLUB (DBC)

Following an enquiry from a committee member a Dogs NZ view was provided in relation to a matter of procedure. Copies of letters sent on 29.08.17 and 06.09.17 were tabled for EC information. In effect the 06.09.17 letter replaced the former given the agreed ambiguity in the DBC rules. The Dogs NZ letter recommended the club seek legal advice in terms of the presentation of rule changes at either a SGM or AGM. It was also suggested at the meeting that contact could be made with Incorporated Societies for advice.

# GERMAN SHEPHERD DOG ADVISORY COUNCIL (GSDAC)

KMcl provided a report from a meeting held on 7 September to which she had been invited to represent EC. The purpose of the meeting was to establish a way forward resulting from an issue with the Breed Surveyors Forms and changes of height. This had caused friction amongst the surveyors and whose responsibility it was to ensure correctness. The report was also provided to the Secretary of GSDAC to include suggestions on meeting protocols.

# 6. REGULATIONS

#### MERLE TO MERLE MATINGS

Following a call for submissions in relation to a proposed ban on merle to merle matings an addition was made to the Registration Regulations:

5.1.6 No progeny resulting from a merle to merle mating in any breed may be registered on either Part 1 or Part 111 of the Register

Moved SM; Seconded ST – passed

A letter was also tabled from the CH&W Committee in response to the one submission specific to the case of Rough & Smooth Coat Collies. The committee shared the concern that the inability to register a dog in its true colour introduced a risk that would make the mating ineffective in some instances. The office will look at the AKC model to see what may be able to be done which would work within the requirements of the Breed Standard.

#### SHOW REGULATION 19.13 – EXCLUSION OF DOGS

Following previous feedback from EC BW & PD tabled amended regulations which in effect had removed one level of behaviour to be addressed. The ensuing discussion requested that the next two lower levels also be removed but they be replaced with a distinction between aggression and attack. Draft amendments will be tabled at the November meeting. The amendments will flow through to the draft Incident Checklist and Report which was also tabled. The current Guidelines for Observers is also to be updated and tabled for approval.

#### SHOW REGULATION 4 – JUDGE APPOINTMENTS/PROMOTIONS

PD had worked with the NZDJA in looking to align the Show Regulations (4.1.2 a & 4.1.2 b) with the NZDJA Regulations in relation to Judge appointments and promotions. A copy of the letter to NZDJA outlining the changes was tabled which they were considering on Sunday, 17 September. It was recommended that the changes to the Show Regulations be made to take immediate effect and be advertised in the October Dog World.

Moved LS; Seconded SM - passed

It was also proposed that it no longer be deemed compulsory for judges to furnish details of overseas appointments. An offer had been made to NZDJA to manage the process. After discussion it was recommended that the clause be removed in its entirety, the fact be advertised in the October World and NZDJA be advised accordingly.

# ANATOLIAN SHEPHERD DOG

A request was received to import semen compatible to an imported bitch owned by a Dogs NZ breeder. PD to check where the dog is physically, from where the semen is to be imported from and will a Certified Export Pedigree be available. BM to also be asked regarding the value of a BITSA (Breed Identification) test.

#### WHITE SWISS SHEPHERDS (WSS)

A request was received to register a WSS bitch and her litter. A pedigree certificate from the Netherlands was provided which was incomplete and appeared to have limitations placed on it. The incomplete sections appear to relate to dogs exported from New Zealand some time ago. PD to make further enquiries of the breeder and check the Registry in relation to the exported dogs.

#### 8. CORRESPONDENCE

#### CHARITABLE TRUST

Correspondence to and from Kelly Martin regarding assistance in establishing a Dogs NZ Charitable Trust was tabled. In effect Kelly advised it was not her field of expertise.

#### SPECIALIST JUDGES

KB presented a letter titled "in favour of specialist judges" highlighting the situation in the USA where it was maintained that AKC was accepting of non-affiliated speciality breed clubs and the judging and exhibiting within these without any consequences. The letter was critical of the New Zealand stance in relation to judging at these shows. KB to draft a letter for PD to send with EC approval to AKC.

#### ADVANCED JUDGING COURSE

A Dogs NZ member had sent detail on a joint Kennel Club and Finnish Kennel Club initiative which has created an advanced judging course entitled "eye for a Dog". EC agreed it was worthy of sending to the NZDJA.
