1. **This Show** is being conducted under the Rules and Regulations of the New Zealand Kennel Club (Incorporated) and the Rules and Regulations of the New Zealand Dog Judges Association (Incorporated). *Available to view and download at <http://www.nzdogjudge.com/Judges%20Regulations.htm>*
2. **Judging** is to be conducted to the recognised New Zealand Kennel Club Show Regulations and the Judge undertakes that before judging, he or she will become fully conversant with such Rules and Regulations as may be relevant. *Available to view and download at <http://www.dogsnz.org.nz/rulesreg.html>*
3. **The Society** will provide all overseas Judges, free of charge, with a copy of the New Zealand Kennel Club Show Regulations and Breed Standards prior to the date of the Show. *Available to view and download at <http://www.dogsnz.org.nz/dogselect.html>*
4. **The Amount** of fees and expenses shown overleaf is subject to approval in advance by the Society conducting the Show (New Zealand Judges note Show Regulation 4.11).
5. **The Club** conducting the Show reserves the right to reallocate one or more classes to another Judge if an excessive number of entries is received.
6. **The Judge** to advise the secretary of the Club whether or not this invitation is accepted. If the reply is not received by the secretary within 21 days of the date of the offer it will have been deemed lapsed.
7. **If the Judges** fees, accommodation and/or expenses are not confirmed by the Club within 14 days of the date of acceptance, it will have been deemed to have lapsed and this contract is at an end.
8. **Air & Other Travel** If a specified mode of travel including conditional methods of air travel is required of or by a Judge these should be specified and full particulars of this travel should be given. In the absence of such specification a Judge is entitled to full economy return air travel on the schedule specified by the Judge (NB The method and responsibility for booking and payment of fares should be clearly agreed upon by the parties to this contract).
