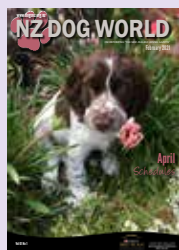

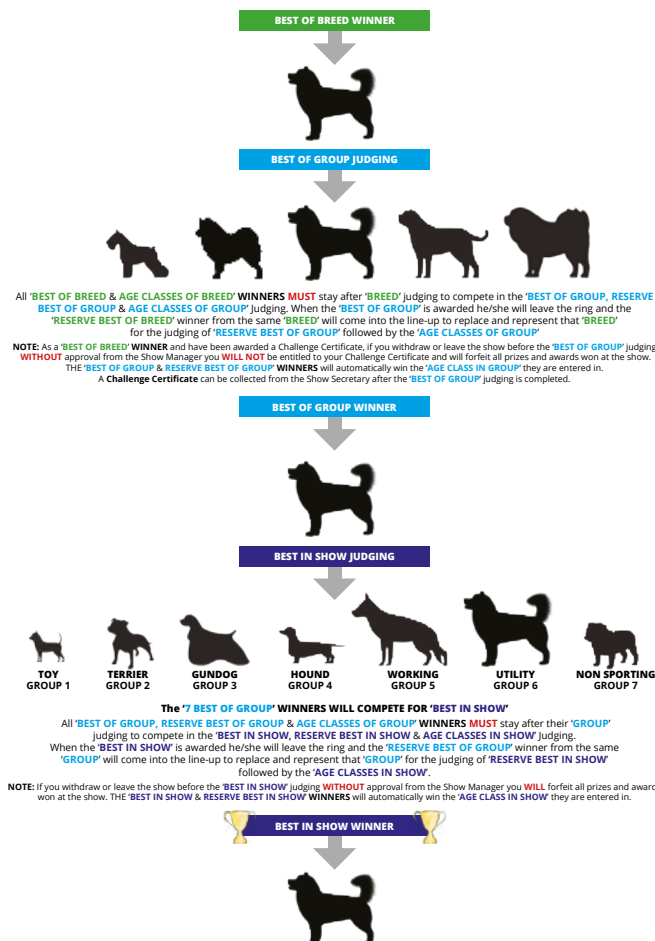

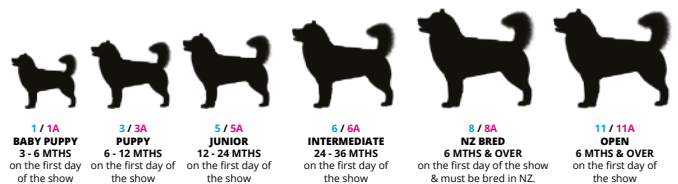

## YOUR NZ 'BEST OF BREED' JOURNEY

Breed judging always commences with the judging of 'DOGS' first.



Each 'DOG' will compete in their entered age class beginning with 'BABY PUPPY DOG' through to 'OPEN DOG' & will be placed 1st, 2nd etc. Every age class 'DOG WINNER' will then compete for 'BEST DOG' (A Judge may also award a Challenge Certificate) & 'RESERVE BEST DOG'. When the 'BEST DOG' is awarded he will leave the ring and the 2nd place winner from the same age class will come into the lineup to replace and represent that age class for the judging of 'RESERVE BEST DOG'.

**NOTE:** Challenge Certificates (CC) are only awarded at a Championship Show for 'Best Dog & Best Bitch'. Challenge Certificates are required to become a New Zealand Champion with the 8th needing to be awarded at over 12 months of age. A Challenge Certificate may be withheld by a judge if they feel the exhibit is not worthy of a Champion title. Baby Puppies are not eligible for a Challenge Certificate until over 6 months of age.

Once all 'DOGS' have been judged through to 'BEST DOG & RESERVE BEST DOG', the same process commences judging for the age classes of the 'BITCHES' through to 'BEST BITCH & RESERVE BEST BITCH'



If the 'DOG' is awarded 'BEST OF BREED' he will leave the ring and the 'RESERVE BEST DOG' will come in & replace the 'BEST DOG' for the judging of 'RESERVE BEST OF BREED'.

After the 'BEST OF BREED & RESERVE BEST OF BREED' has been judged, all age classes for 'BREED' will then be judged beginning with 'BABY PUPPY OF BREED'.

E.g. The 'BEST BABY PUPPY DOG & BEST BABY PUPPY BITCH' will compete to become the 'BEST BABY PUPPY OF BREED'.

**NOTE:** 'BEST OF BREED' & 'RESERVE BEST OF BREED' will automatically be the winner of the 'AGE CLASS OF BREED' they were entered in.

### ADDITIONAL AGE CLASSES FOR SPECIALTY SHOWS

**NOTE:** MINOR PUPPY CLASS MAY ALSO BE INCLUDED AT CHAMPIONSHIP ALL BREEDS SHOWS. AGE CLASSES ARE REPEATED WITH NUMBER. BITCHES will always have 'A' after the Age Class number. E.g. 3 / PUPPY CLASS - PUPPY DOG IS '3' & PUPPY BITCH IS '3A'

2 / 2A - MINOR PUPPY = 6 - 9 MTHS on the first day of the show

4 / 4A - NOVICE = 6 MTHS & OVER

That have not won a first prize except in a Baby Puppy Class under six months of age at any Open or Championship Show, up to the time of closing of general entries at any Recognised Show whatsoever.

7 / 7A - LIMIT = 6 MTHS & OVER

Which have not won more than four Challenge Certificates up to the time of closing of general entries at any Recognised Championship Show. Overseas Champions cannot compete in Limit Class in New Zealand.

9 / 9A - STUD DOG/BROOD BITCH

For dogs which have sired one or more registered litters. For bitches which have whelped one or more registered litters.

10 / 10A - VETERAN

For dogs or bitches seven years or over on the first day of the show.
